

## **Privacy Statement AZIMUT Hotels**

We are pleased that you are visiting our Homepage and thank you for your interest in our company. Dealing with customers and visitors is a matter of trust. We highly value the confidence you have placed in us and consider it an important obligation to handle your information carefully and protect it from any misuse.

To ensure that you feel safe and secure while visiting our website, we take the protection of your personal data and confidentiality very seriously. We therefore operate in accordance with the current laws on data protection and security.

In this privacy statement we would like to inform you about when we store certain types of data and how we use them – of course, this is done in compliance with current German legislation. Privacy in AZIMUT Hotels is specifically based on the current Federal Data Protection Act (BDSG). When using the internet, the protection of your personal data is based on the German Telemedia Act (TMG) of the Republic of Germany.

### **Collecting and processing personal data**

In principle, you can visit our websites without telling us who you are. Every time a user accesses a page on the internet and every time a file is opened, information about this process is stored in a log file. This is not personal information, so we cannot determine which user has accessed which data.

In particular, the following data is stored each time a file is opened:

- Date and time of opening the file,
- Amount of data transfer,
- Report of whether or not the file was opened successfully,
- Description of the type of web browser used.

Personal user profiles cannot be formed. The saved data is only used for statistical purposes.

Under statutory provisions, we collect and process contact details when bookings are made through our website or during the stay in our hotels, if such details are necessary for proper. mutual fulfillment of the contract. These include:

- Form of address
- First and last name
- Address, street, city
- Date of birth
- Telephone numbers and/or email addresses
- Passportnumber (according to the Federal Registration Act)
- Payment details (bank details)
- Information on services provided

In general, we only collect, process or use your personal data when you have provided this voluntarily and this is legally permitted or you have given consent.

Should we wish to process or use your personal data for other purposes, and there is no legal permission to do so, we will ask for your consent. You can give your consent electronically. We draw

your attention to this opportunity within our services, should the need arise.

You can, of course, revoke your consent at any point in the future. For this, you can send an email to [info.europe@azimuthhotels.com](mailto:info.europe@azimuthhotels.com).

### **Using the data collected**

We only use the personal data you have provided for the purposes we have explained above, or for other agreed purposes; that is, usually, for responding to your inquiry or for providing information about current offers from our company.

If you are making use of our services, we will only usually collect the data that we need to provide those services. If we ask for further information, it will be provided voluntarily. We only process the personal data in order to carry out the requested service and to protect legitimate business interests.

### **Consultation, advertisement and market research**

Our good customer service means that we keep you regularly informed of current offers. We would therefore like to use your contact data to send you mailings. This will only be done with your express consent. Of course, you can cancel this at any time by letter or email.

For advice and advertising from corporate customers, we collect and use additional contact, phone number and mailing information. We only use this contact information for our own purposes and for appropriately arranging business activities. Permission to use these details may be withdrawn at any time by writing, telephone or email.

For the opportunity to give a review on our website for the purposes of quality management and hotel review by guests we integrated the hotel review software of tripadvisor. Former guests can write a hotel review after Check-Out, which will be published anonymously. Therefore we would like to send an email within 14 days after your departure, to ask you to give us a hotel review. You can, of course, revoke your consent or not to carry out the review.

### **Will personal data be disclosed to third parties?**

Personal details will be transferred or disclosed for central functions. Your personal data will be stored from our internet website onto the server of a service provider when making a booking. When this occurs, all matters of data protection and security are taken care of. Appropriate data protection agreements have been made with the service provider.

When you make an online booking through our website, this takes place through the online reservation system of Travelclick Inc. All the booking information you enter is encrypted. Travelclick take all organizational and technical measures to protect your information.

### **Privacy Policy for use of the Facebook plugin (like button)**

On our pages, plugins are integrated of the social network Facebook, 1601 South California Avenue, Palo Alto, CA 94304, USA. The Facebook plugin you acknowledge by the Facebook logo or the "Like Button" ("Like") on our pages. An overview of the Facebook plug-ins can be found

When you visit our pages, using the plugin a direct connection is made between your browser and the Facebook servers. Facebook thereby obtains the information that you have visited our site and IP address. This allows Facebook to assign your visit on our pages to your account. We point out that we as provider of the sites have no knowledge of the contents of the transmitted data and the use of them through Facebook. ### **Forwarding to Google Analytics**

This website uses Google Analytics, a web analytics service provided by Google, Inc. ("Google"). ### **Use of Cookies**

To ensure that you are satisfied with our services, we may use cookies or other forms of technology to enable us to analyse user behaviour. This takes place anonymously, and it is not possible to conclude that you are the user in question. We use this data in order to provide optimal services. The data is only stored temporarily, until an analysis has been carried out anonymously. After this, the data is deleted permanently.

Note | A cookie is a small text file which is transferred from a web page onto your hard drive. Cookies do not harm your computer and contain no viruses.

### **Security**

The AZIMUT Group applies technical and organisational security measures in § 9 of BDSG to protect the data you have given us from accidental or intentional manipulation, loss, destruction or access by unauthorized persons. Our security measures are continuously improved in line with technological developments. Access is limited to a few authorized personnel who are specifically committed to dealing with data privacy and are involved in the technical, administrative or editorial management of this data.

#### **User declaration of consent**

By using our website and the offers contained therein, you hereby agree that you have voluntarily provided us with personal data that we have stored and will process and use in accordance with this privacy statement.

#### **Data transmission to third country**

The AZIMUT Group is an international company, headquartered in Moscow. Therefore data to specific purpose are transferred to fulfill the tasks to the corporate headquarter. Your data will not be sold, rented or in any other way provided to third parties. Transfers of personal data to official institutions and authorities only takes place if required by law.

#### **Right of information / Public procedural directory**

According to § 34 and § 6b of BDSG, you have the unlimited right to free information about your stored data, as well as the right to delete or block unauthorized data or the right to correct inaccurate data in accordance with § 35 of BDSG.

If you request it, we are happy to provide you with written information about whether or not we have stored personal information about you, and which information in particular. Where possible, we will take appropriate steps to update or rectify your data stored with us at short notice. In such cases as these, please contact our management directly.

The Federal Data Protection Act (BDSG) stipulates in § 4g that privacy-related information must be made available to everyone in an appropriate form. The AZIMUT Hotels have provided the appropriate information in their public procedural directory for your perusal.
